## MINUTES OF THE NEIGHBOURHOOD PLAN WORKING GROUP MEETING

#### CONSULTANT

Cllr. Bedford introduced Louise Kirkup from Kirkwells a consultancy specialising in town planning and neighbourhood plans.

Ms Kirkup explained that as a company they had already been involved with 150 parish and town councils in helping them to devise their neighbourhood plan.

She would be able to help in the following ways:

- The writing of the final document
- The collecting of evidence
- Access to funding
- Production of a 20 page 'Issues and Options' document following initial 'Group Visits' using the group's notes
- By attending 4-5 meetings a year

With reference to funding, Ms Kirkup explained that current funding was available for costs until the end of March when a new batch of funding would be available. Money was usually available within 2-3 weeks.

It was decided to apply for some interim funding to help with the following:

- initial information gathering
- typing up notes
- more advertising (Thorne Times, Thorne Radio)
- help with including information on the website
- a launch event.

It was noted that funding could not be applied for retrospectively.

#### INTEREST GROUP VISIT REPORTS

**Businesses** Cllr Bolton and Mr Turner had visited the shops on Kirton Lane. Cllr Bolton was aiming to have finished talking to the businesses by the end of January.
